Confidentiality Laws for Foster Parents

Are you following them?

Understanding and upholding lowa's confidentiality laws is one of the most complex issues for foster parents to adhere to. These laws are intended to protect the privacy of foster children and their biological families. All information regarding foster children, which is obtained through or from the Department of Human Services is confidential, according to lowa Code. This includes identifying information such as name, social security number, age, sex, weight, height, contact information on the family, physical and mental health conditions, etc.

WHAT IS CHILD SEXUAL ABUSE?

A new fact sheet developed by the National Sexual Violence Resource Center (NSVRC), What Is Child Sexual Abuse?, highlights various forms of sexual victimization and their distinctive signs and symptoms. This fact sheet summarizes common behavioral red flags displayed by sexually abused children. A checklist of warning signs to help with the detection and identification are also provided, including:

- Bodily signs (i.e., bedwetting, stomachaches)
- Emotional signs (i.e., fear, sadness, acting out)
- Sexual signs (i.e., inappropriate sexual behavior)
- Verbal signs (i.e., non-age-appropriate sexual activities)

If Congress does not act, the tax credit as we know it will expire on December 31, 2012. And as the law currently stands, the adoption credit is not refundable for 2012 as it was in 2010 and 2011.

On Friday, September 21, Senators Landrieu (D-LA), Blunt (R-MO), Hutchison (R-TX) and Cardin (D-MD) introduced **S. 3616 – Making Adoptions Affordable Act** (the companion to House bill H.R. 4373). There are now bills in both the House and the Senate that would accomplish the goal of an adoption tax credit that is inclusive of all adoption types, flat for special needs adoptions, refundable, and permanent.

When will this be considered in Congress?

The adoption tax credit is likely to be included in a package of other tax credits to be considered by Congress sometime after the November election. At this time, it is uncertain whether Congress will make the adoption credit refundable in any end-of-year extension. The North American Council on Adoptable Children (NACAC) is working hard to get refundability included and need your help to show members of Congress that refundability helps foster care adoption and lower to middle income tax filers. One of the most effective ways is for families to tell their members of Congress personal stories of how refundability affects their adoption story.

Action:

Please **e-mail or call your two U.S. Senators** and ask them to cosponsor S. 3616. If you need to find your Senators, visit the following link:

http://www.senate.gov/general/contact_information/senators_cfm.cfm. If you are planning to call, you can call the Capitol Operator at 202-224-3121. Once you reach the Senator's office, ask to talk with the legislative assistant who deals with adoption or tax issues. (You'll have to call back to reach the second Senator.) If you have not already contacted your member of the House of Representatives to ask him or her to co-sponsor H.R. 4373, a similar bill on the House side, you can also do that now. You can use the contact information you find at that link or call Capitol Operator number above to reach your Representative.

NEW CASEY SKILLS ASSESSMENT

Effective immediately, there is a new version of the Ansell Casey Life Skills Assessment or "CLSA"! lowa utilizes this assessment as a "tool" to identify life skills strengths and needs for youth in out of home placement starting at age 16.

For those of you who have used the old version of the assessment, it will go off-line on September 30, 2012. You will no longer follow the previous instructions/ procedures to log into the website. Please delete all previous instructions to date as they are no longer accurate. The youth's JCO/DHS worker will send an email to the provider/foster parent or youth with a link for that youth to access the assessment. If you have not received an email request, but the youth would like to complete the CLSA, please request the email link from your worker. If your youth does not have access to email, a hard-copy can be given to them instead. DHS asks that provider agencies do not go to the website and "Create their own account" as this will not allow the youth to have ongoing access to their assessments if their provider changes. Also having youth complete assessments under a provider account may create confidentially issues for the youth.

DHS has created a short webinar for you to view that will explain the process of how to have your youth take the CLSA, and how to use the results of the assessment to continue to work with the youth on improving their life skills for chances of a more successful transition to adulthood.
